The Penn Center for Public Health Initiatives (CPHI) is responsible for contact tracing of suspected and confirmed COVID-19 cases for Penn faculty, staff and postdocs. Lab members are asked to suspend experiments, return home, and wait for more guidance. Typically this shutdown process occurs within 1-3 hours after case notification. This information was included in the mandatory EHRS training and has been previously distributed to the SEAS community. In this case in Skirkanich, the process was followed. EHRS was notified and provided guidance. The researcher tested negative, but will remain off campus for at least 14 days. Out of precaution, the lab was disinfected before resuming work. Following CDC guidelines, the risk was assessed as low and the particular lab members are permitted to resume work. Only the lab members with potential exposure were notified.
